ADJUDICATION ORDER

Pursuant to a meeting of the Ohio Architects Board, the following matter came before the Board on December 12, 2014. Members of the Board present were: Stephen L. Sharp, Richard L. Bowen, John P. Rademacher, Monica J. Green and Christopher P. Meyers.

ORDER OF THE BOARD

Stephen L. Sharp, Richard L. Bowen, John P. Rademacher, Monica J. Green and Christopher P. Meyers reviewed and considered the evidence received in this matter related to Mr. Frederick's alleged failure to successfully complete the annual continuing education requirements for the year 2013.

It should be noted that Mr. Frederick, who received via certified mail, a Notice of Opportunity letter dated August 29, 2014 refused to request an administrative hearing within (30) thirty days and refused to accept a proposed settlement agreement as offered by the Board. Mr. Frederick also failed to complete and return an Emeritus Architect application which was offered to him on October 1, 2014.

Thereupon, the Board took the following action in this matter:

1. John Kuehn Frederick's certificate of qualification to practice architecture in Ohio, Certificate No. 4880, is hereby *REVOKED*.

John Kuehn Frederick is hereby officially informed that Ohio Revised Code Sections 4703.06 (A), 4703.18 (A) and 4703.99 make it a violation to assume or use the title or designation of "Architect" or "Registered Architect", or to hold himself out to be any of the above, or to engage in the practice of architecture unless properly licensed to do so by the Board.

The Board hereby orders you to immediately **cease and desist** any further use of any of the aforementioned designations, performing any of the aforementioned work, or to in any way hold yourself out to be qualified and permitted to practice as an "Architect" in the state of Ohio.

The use of any advertisements, letterhead, business cards, signs, or other materials that in any way improperly portray you as a practitioner within Ohio should be stopped.

TIME AND METHOD TO PERFECT AN APPEAL

Any party desiring to appeal shall file a Notice of Appeal with the Ohio Architects Board, 77 South High Street, 16th Floor, Columbus, Ohio 43215-6108, setting forth the order appealed from and stating the Board's order is not supported by reliable, probative, and substantial evidence and is not in accordance with law.

The Notice of Appeal may, but need not; set forth the specific grounds of the party's appeal beyond the statement that the Board's order is not supported by reliable, probative and substantial evidence and is not in accordance with law.

The Notice of Appeal shall also be filed by the appellant with the Court of Common Pleas in the county of the appellant's place of business, or in the county in which the appellant is a resident, or with the Court of Common Pleas in Franklin County, Ohio if not a resident of Ohio. Such notices of appeal shall be filed within fifteen (15) days after the mailing of the notice of the Board's order as provided in Section 119.12 of the Ohio Revised Code.
