## ADJUDICATION ORDER

Pursuant to a meeting of the Ohio Architects Board, the following matter came before the Board on July 16, 2010. Members of the Board present were: Richard L. Bowen, Jeffrey Skapin, August L. Fluker, Jr., Richard J. Fleischman and Stephen L. Sharp.

### ORDER OF THE BOARD

Richard L. Bowen, Jeffrey Skapin, August L. Fluker, Jr., Richard J. Fleischman and Stephen L. Sharp reviewed and considered the Report and Recommendation of the hearing officer and the written objections submitted by Mr. Brice.

Thereupon, the Board took the following actions in this matter:

1. The Board approves and adopts the findings of fact, conclusions of law; and recommendation as set forth in the Report and Recommendation.
2. Mr. Brice is hereby ordered to pay in full, a monetary fine of \$500 / Five-Hundred Dollars to the Board no later than January 21, 2011. Check or money order made payable to the "Ohio Treasurer, Richard Cordray".

Mr. Brice is permitted to make minimum monthly payments of at least \$83.33 due the 21st day of each month, with the first payment due on or before August 21, 2010.

3. Should Mr. Brice fail to make the minimum monthly payments set forth by the Board, or fail to pay the total fine by January 21, 2011, his license will be revoked.
4. Mr. Brice may apply for reinstatement of his certificate of qualification to practice architecture in Ohio after he completes the mandatory continuing education requirements and has paid the \$500 fine in full.

**CERTIFICATION**

I hereby certify that the foregoing Adjudication Order of the Ohio Architects Board is true and accurate as it appears in the journal of the Board at its proceedings on July 16, 2010.

This order may be appealed in accordance with Section 119.12 of the Ohio Revised Code by filing a Notice of Appeal with the Ohio Architects Board, 77 South High Street, 16<sup>th</sup> Floor, Columbus, Ohio 43215-6108, and also a copy of that Notice of Appeal with the Court of Common Pleas in the county of the respondent's place of business, or in the county in which the respondent is a resident, or with the Court of Common Pleas in Franklin County, Ohio if not a resident of Ohio.

Such notice of Appeal shall contain the Order appealed from and the grounds of such an appeal. Such notice of Appeal and copy shall be filed and must be received within fifteen (15) days after the mailing of this Adjudication Order.


